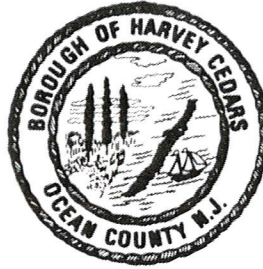

ORDER PURSUANT TO THE PROCLAMATION OF DISASTER AND EMERGENCY

TO ALL RESIDENTS AND PERSONS WITHIN THE BOROUGH OF HARVEY CEDARS IN THE COUNTY OF OCEAN AND STATE OF NEW JERSEY AND TO ALL DEPARTMENTS OF THE MUNICIPAL GOVERNMENT OF THE BOROUGH OF HARVEY CEDARS

WHEREAS pursuant to the powers vested by Chapter 251 of the laws of 1942, as amended and supplemented, N.J.S.A. App. A: 9-30, *et seq.*, N.J.S.A. 40:48-1, *et seq.*, and all applicable statutory law and regulations, the Borough of Harvey Cedars declared on March 24, 2020, that a local disaster/emergency exists within by and through the required authorization of the Mayor and the Emergency Management Coordinator; and

WHEREAS in order to protect the public health, welfare, and safety during this pandemic and aid in the enforcement of Executive Order 107, on April 7, 2020 the Borough of Harvey Cedars executed Harvey Cedars Order No. 2 closing the beaches located in the Borough with limited exceptions.


NOW, THEREFORE, in accordance with the aforesaid laws and recitals, which are incorporated herein by reference, it is promulgated and declared that Harvey Cedars Order No. 2 executed on April 7, 2020 is hereby **rescinded**, and until further Order of the Borough or until the restrictions set forth in the Governor's Executive Order 107 are rescinded, whichever is earlier, the following emergency restrictions and regulations for beaches are effective immediately.

- A. Public access and use of the beach shall be on foot only.
- B. No unauthorized vehicle use shall be permitted on the beach.
- C. No congregating of any kind outside the scope of the requirements of Executive Order 107.
- D. All social distancing guidelines shall apply.
- E. The Emergency Management Coordinator, the Borough Police Department and the Borough Beach Patrol shall be charged with the enforcement of the terms of this Order.
- F. Penalties for violations of this Order may be imposed under, among other statutes, N.J.S.A. App. A:9-49 and -50.
