## Resolution – 2021:09 – Levanic Inc. – Resolution Amendment

**Kevin Quinlan Esq.** shared with the board that the applicants of **2021:09** were unable to obtain building permits due to certain circumstances. He explained that the applicant was unaware of the one-year expiration of the resolution and is searching for a way to move forward with a potential extension. Since the application had no opposition and received a unanimous approval, he believes that the board has the power to grant an amendment to the resolution extending the

expiration date. **Kevin Quinlan** explained to the board that they could grant the extension, request an amended application, or request an entirely new application from the applicants.

**Mayor Jonathan Oldham** stated that since the board hasn't changed and they are still requesting the same variance that he sees no issue with the extension.

**Tony Aukstikalnis** questioned the new date of expiration. **Kevin Quinlan Esq.** explained that the initial resolution expired October 21, 2022. **Mayor Oldham** suggested an extension of 18 months.
