Saul Ellman, 82<sup>nd</sup> Street asked if the Commissioners had learned anything from this project through the course of the process, which Mr. Ellman claimed to be a four-year process. Mr. Elman pointed out that the delay in action of the project resulted in inflation on pricing and other hurdles.

Mayor Oldham explained that between required surveying, design work, and working with the County and private property owners to gain permission to make improvements on County and private property, the project took more time than expected. Mayor Oldham continued by stating that we now have the framework and designs to move forward with current and future plans. Oldham also stated that he is hopeful to get more money from the County for future work on the Long Beach Boulevard Streetscape Project.

#### PRIVILEGE OF THE FLOOR -

Jim Fritz, 82<sup>nd</sup> Street expressed his views regarding the recent "Meet the Candidates" election campaign gathering at a Taxpayers Association meeting, stating he thought the event went very well. Mr. Fritz added that he was however disappointed about the "cheap shots" going on with the current campaign, further stating that campaign signs were being wrongfully removed, and that this race was getting very political.

Commissioner Rice stated that he had signs out at the last campaign in 2019 and there were no issues with them at that time.

Linda Kragie, 75<sup>th</sup> Street asked Mayor Oldham if he had abandoned the residents of 75<sup>th</sup> Street with regards to getting the promised fire hydrant installed. Mayor Oldham explained that the holdup was caused due to an electrical wire that was found underground where the hydrant was to be installed. Oldham stated that the Department of Public Works is currently working on a solution. Linda Kragie expressed frustration and stated that the residents of 75<sup>th</sup> street were initially told the job would only take 2 weeks.

Susan Kramer, 80<sup>th</sup> Street stated that she recently learned that there is asbestos in the town drinking water. Ms. Kramer stated that she's been drinking town water all of her life and had concerns. Mayor Oldham explained that PCP water piping is used regularly for water delivery. Harvey Cedars has been changing out the PCP piping with regular projects and before paving is done on streets. The asbestos is not in the drinking water, the pipes are made up of the material. Testing on water is done regularly. Mayor Oldham continued the conversation with other residents explaining the water delivery service process, water main connections and the kind of piping that is used throughout the town.

Joe Gieger, 77<sup>th</sup> Street stated that he was disappointed that all of the older pipes had not

been removed prior to the paving project. Mayor Oldham expressed that replacement of the pipes has been in the plans and many options have been looked at to figure out the best way to go about replacing the underground pipes. Older PCP pipes are being replaced when work on roads is done and before any new paving projects. Mayor Oldham also stated that we are always looking to get grant money that may be available so that less of the financial burden falls on Harvey Cedars residents.

Walt Naisby, 75<sup>th</sup> Street had questions regarding underground water pipes with directional drilling. Mayor Oldham explained the process and plans in place for town water supply and delivery.

Sual Ellman, 82<sup>nd</sup> Street asked about available funding to replace older water pipes, and if Long Beach Twp. is responsible for any of the associated costs. Mayor Oldham answered that Long Beach Twp. pays their portion of our water expenses which is based on Long Beach Township's water usage demand from Harvey Cedars. The estimated cost to replace the pipes is between two and three million dollars.

Commissioner Imperiale announced that he wanted to address the "Dirty Politics" comment that had been made earlier in the meeting. He continued by stating that he did not have campaign signs up, and he did not think that the signs looked good. Commissioner Imperiale further stated that he didn't put them up, or take them down. He explained that he had heard complaints from residents and commercial properties who were not happy to have signs placed on their property without permission.

Commissioner Imperiale thanked the Police Department and Danielle Tilton for a job well done on fulfilling the requirements for accreditation. He congratulated the entire department on all of their hard work.

#### **ORDINANCE NO. 2023-14**

## AN ORDINANCE OF THE BOROUGH OF HARVEY CEDARS, OCEAN COUNTY, NEW JERSEY AMENDING CHAPTER XIII ENTITLED "ZONING" AS IT PERTAINS TO INSTALLATION OF POOLS

### THE BOARD OF COMMISSIONERS OF THE BOROUGH OF HARVEY CEDARS DOES ORDAIN AS FOLLOWS:

- Section 13-7.4 entitled "Permits" is hereby amended by supplementing the following sentence to the end of the paragraph: All pool construction and inspections must be completed within 60 days of the issuance of a pool permit.
- Section 2. Section 13-17.5 entitled "Swimming Pools." is hereby supplemented by adding paragraph f. as follows:
  - f. *Dewatering*. No dewatering shall be permitted between the Friday before Memorial Day and Labor Day of any calendar year. All dewatering for swimming pools, including excavation and seasonal draining, shall be completed within 15 days from the start of the pumping.

Groundwater pumped to the surface either during construction or for any other maintenance requirements must be directed via flex pipe with a silt bag/filter (properly maintained) into the nearest storm drain or into the bay or lagoon if the pool location is along the bay or lagoon. No dirt, silt, sand or runoff debris of any kind shall be permitted or caused to accumulate on a public street or any body of water. No rubbish, debris or litter of any kind shall be permitted to remain or accumulate in or about the swimming pool during construction.

- <u>Section 3</u>. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.
- Section 4. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions.
- <u>Section 5</u>. This Ordinance shall take effect upon final adoption after publication in accordance with law.

WHEREAS, it is the desire of the Board of Commissioners of the Borough of Harvey Cedars to enter into two (2) agreements with the County of Ocean for the purpose of setting forth the terms and conditions regarding the assignment of police officers employed by the Borough of Harvey Cedars to the DWIEP and the MOLEP.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Borough of Harvey Cedars, County of Ocean, State of New Jersey that the Mayor and Municipal Clerk are hereby authorized to execute Shared Services Agreement with Ocean County for the Driving While Intoxicated Enforcement Program and the Move Over Law Enforcement Program, copies of which are on file in the Municipal Clerk's office, effective October 1, 2023 through September 30, 2024.

### URGING THE APPOINTING AUTHORITY IN THE STATE OF NEW JERSEY TO CHOOSE A RESIDENT OF OCEAN COUNTY TO SIT ON THE BPU

WHEREAS, the New Jersey Board of Public Utilities is the state agency with authority to oversee the regulated utilities, which provide critical services such as natural gas, electricity, water, telecommunications, and cable television; and

WHEREAS, the law requires the BPU to ensure safe, adequate, and proper utility services at reasonable rates for all customers throughout New Jersey; and

WHEREAS, Ocean County has, for years, called upon the appointing authority in the State of New Jersey to choose a resident of Ocean County to sit on the BPU in order to provide a needed voice to represent the unique characteristics and challenges faced by communities located along the coast of the State; and

WHEREAS, the population of Ocean County continues to grow with both fulltime and seasonal residents increasing the need for assurances by utility companies to provide uninterrupted service and to make certain equipment is maintained and adequately updated; and

**WHEREAS,** Ocean County currently has a year-round population of 650,000 residents with the number steadily increasing in the summer/warm weather months to more than 1.3 million people; and

WHEREAS, it is imperative that with the increase in population, energy and utility demands are met without interruption of service, and our residents, visitors and businesses are confident in all utilities working properly and available for their needs; and

WHEREAS, coastal counties are more prone to serious weather conditions including hurricanes, nor'easters and most recently tornadoes, which can result in power outages, utility poles down and a host of safety issues; and

WHEREAS, Ocean County residents have experienced the likes of Hurricane Irene in 2011, Superstorm Sandy in 2012, Tropical Storm Isaias, an April 1, 2023 tornado, and widespread summer power outages in the summer months dating back to July 2003 that devastated the height of the summer tourism season; and

WHEREAS, any type of lengthy power outages especially during the tourism season, which produces \$7 billion in revenue for Ocean County alone, can result in many residents and businesses, both full time and seasonal, experiencing a financial loss due to having to discard food and medication, and loss of wages; and

**WHEREAS,** adding to the concern, Ocean County also is home to more than 200,000 senior citizens. An aging population is often more reliant on medical devices that

use power for their health needs, and these are people that are fixed income that does not allow extra money to replace food and prescriptions spoiled by power outages or any challenges posed by other utility issues; and

WHEREAS, utility interruptions can also create safety hazards for residents and visitors along with emergency responders tasked to assist during these times; and

WHEREAS, without a voice on the BPU, Ocean County and similar coastal communities, face an uphill battle with the utility companies in getting help for residents and businesses; and

WHEREAS, coastal counties like Ocean have unique characteristics - from its land size, population shifts based on time of year, economically and geographically - that the current members of the BPU are not as familiar with as a resident of Ocean County would be; and

**WHEREAS,** the current sitting members of the Board of Public Utilities are from Essex, Camden, Morris, and Somerset; and

WHEREAS, in the absence of a member from Ocean County, the BPU in the meantime, should designate one of its current members as liaison to the area in order to address concerns or create alternate positions to be filled by residents of Ocean and/or Monmouth County.

NOW, THEREFORE, BE IT RESOLVED that Board of Commissioners of the Borough of Harvey Cedars, County of Ocean, hereby requests that the opening on the Board of Public Utilities to go to a qualified individual from Ocean County in order to assure representation of the interests of the residents and businesses of Ocean County and all shore communities.

**BE IT FURTHER RESOLVED** that the Borough of Harvey Cedars urges Governor Murphy and the Senate recognize that as the population continues to grow, and people continue to move to Ocean County to raise a family or retire, the need for representation on the BPU also increases providing coastal communities with a needed voice on the Board. And in the absence of a member from the Jersey Shore, the BPU at a minimum, should designate a liaison to this area to address ongoing concerns.
