POLICE DEPARTMENT PRESENTATION-

Commissioner Imperiale welcomed Officer Tirella to the Harvey Cedars Police Department. Commissioner Imperiale pointed out some of the fine qualifications of Mr. Tirella which made him a top pick for the Harvey Cedars Police Department. Imperiale expressed his pride in the entire department and emphasized his confidence that Officer Tirella will be a great addition to an already excellent team and community.

OATH OF OFFICE- Officer John Tirella

Commissioner Imperiale administered the Oath of Office for Officer Tirella. The Board and members present congratulated and welcomed Officer Tirella. Commissioner Imperiale thanked Chaplain Wesley Smith for coming out and for always supporting the Harvey Cedars Police Department.

#### TOPICS OF INTEREST -

Commissioner Imperiale thanked everyone for their support and wished everyone a great holiday season.

Commissioner Rice stated the Finance Department was starting budget planning for the new year. He also wished everyone a very happy holiday season. Rice expressed that he was looking forward to year 2024.

PRIVILEGE OF THE FLOOR -

Kathy Ries, President of the Taxpayers Assassination asked for updates on the Streetscape and Beach Replenishment Projects. Mayor Oldham stated that work on the Streetscape Project should start soon, work should be done off-season and announced that the Borough has been awarded grants for Phase II of the Project. Oldham stated that the DEP and Wildlife are currently working out differences to establish where sand will come from for the Beach Replenishment Project. The Mayor stated that he hoped the project would start shortly as to not disturb the beaches in the summer months. Jim Fritz, 82<sup>nd</sup> Street relayed a question which had been asked at the Taxpayers Association regarding signage for the Barnegat Light Yacht Club on Borough property, specifically the corner of 76<sup>th</sup> Street, and if a resolution was passed to allow for it. Mayor Oldham stated that a resolution was not done to allow the sign, and that he had felt the sign should have only been seasonal.

Barry Sziklay, Suffolk Place stated his concern for the size of new homes being built in his neighborhood. Mr. Sziklay asked about the oversight of building and zoning. Mayor Oldham and Commissioner Imperiale expressed that zoning oversight was strictly regulated by our Zoning Officer. Any deviation from our zoning code would first have to be approved by our Land Use Board. Mayor Oldham did offer that most new homes do tend to maximize on permitted limits.

Commissioner Rice stated that building trends in relation to home size are directly linked to property values. Expensive properties will tend to have larger homes build on them stated Rice.

Mayor Oldham stated that during his time as mayor, many zoning changes have been made to regulate and control the size of homes that are permitted to build in Harvey Cedars. Mayor Oldham also stated that while smaller homes are nicer to look at, property owners do not like having limitations set as to what they are permitted to do with their property.

Walt Naisby, 82<sup>nd</sup> Street asked about who regulates and determines when beach replenishment was required. Mayor Oldham answered that several agencies regulate beach replenishment, a seven-year replenishment is typical. Funding is always the issue. Oldham stated that approximately fifty million dollars is slated to fund the replenishment project on Long Beach Island in the current replenishment phase.

Mayor Oldham announces that he did not appreciate his integrity being questioned in a recent article of the Sandpaper. Oldham offered that while everyone has the right to write whatever they want, reports that he had been dishonest were inaccurate and misguided. Oldham finished by stating that his integrity is very important to him. He ended his statements by wishing the newly elected commissioner well in the coming year.

WHEREAS, the Township of Long Beach as Lead Agency had elected to award a contract for professional legal services to Pashman Stein for legal services relating to Phase I of the opposition of the Atlantic Shores Offshore Wind Project per Harvey Cedars Resolution #2023-071, collectively with the Boroughs of Barnegat Light, Beach Haven, Harvey Cedars, Ship Bottom and Surf City; and

WHEREAS, the Phase I Legal Services have concluded; and

WHEREAS, the Township of Long Beach has agreed to secure additional legal services from Pashman Stein relating to the Township's opposition to the Atlantic Shores offshore wind project, specifically (i) the filing of a lawsuit seeking a declaration that the NJDEP is not impartial and seeking an order directing a plenary hearing before an administrative law judge and (ii) submit a supplemental comments letter providing the NJDEP with the visual impact study and other information by the October 19th filing deadline (collectively "Phase II Legal Services"); and

WHEREAS, the Island Municipalities and the City of Brigantine ("Brigantine") have indicated a desire to participate and contribute to the Phase II Legal Services secured by the Township; and

WHEREAS, the scope and terms of Pashman Stein's amended representation of the Township are more fully set forth in the engagement letter dated October 13, 2023 ("Second Engagement Letter"), including, but not limited to, the hourly rates, the scope of the work and the cap of the professional fees; and

**WHEREAS**, no expert fees or additional professional fees shall be authorized without the prior written approval of the Township; and

WHEREAS, the Borough desires to participate in and contribute to the scope of Legal Services set forth in the Second Engagement Letter with the Township designated as the lead agency pursuant to the terms set forth herein; and

WHEREAS, each of the municipalities have retained Pashman Stein as special counsel for the Phase I Legal Services and intend to amend the terms of Pashman Stein's legal representation to include the Phase II Legal Services in accordance with the terms of this Second Engagement Letter and this Agreement.
