## HARVEY CEDARS, NJ

The regular meeting of the Board of Commissioners of the Borough of Harvey Cedars, NJ was called to order by Mayor Oldham at 4:40pm. Commissioner Gerkens was present and Commissioner Garofalo was in Florida.

The Mayor asked all to rise for the Pledge of Allegiance.

Pursuant to the applicable portions of the New Jersey Open Public Meetings Act, adequate notice of this meeting has been given. The Mayor asked for a **motion** to open public discussion regarding the 2016 Ocean County Community Development Block Grant (CDBG) funding and stated that citizens and nonprofit agencies are invited to comment on the housing and community development needs of the Borough. Motion: Commissioner Gerkens

Commissioner Gerkens explained CDBG is earmarked for low income areas, seniors, and/or handicap accessible projects. Since Harvey Cedars no longer has a Designated Target Neighborhood (low income) or senior centers, the Borough can only apply for handicap accessibility projects; the County rotates funding every 2 years to most towns, but larger towns receive their own share; it is a Federal grant that is distributed to States and administered by Counties. The last grant Harvey Cedars received was under \$35,000.

Bob Danna suggested hard, compact beach walkover surfaces for the elderly residents and transportation to the beach. Commissioner Gerkens said the walkovers must be the correct slope ratio to be considered as handicap ramps. The Mayor stated the Township uses a

Mule (ATV vehicle) to assist residents. Commissioner Gerkens stated we will check to see if a vehicle of that type is feasible for the funding, otherwise we can apply for beach wheelchairs.

PRIVILEGE OF THE FLOOR -

Bob Danna stated a request was made through the Taxpayers Association that the summer construction hours be implemented throughout the year. This was requested by an individual, not the Association as a whole. The Mayor asked for suggestions from the Association to be submitted and the Board will review them; the hours currently in place were based on what other towns have and what was reasonable (for homeowners as well as contractors).

The Mayor stated he recently spoke to Barnegat Light's Mayor Kirk Larson about their Open Space Tax. Barnegat Light had approximately \$800,000 collected which was recently used towards the purchase of the Coast Guard housing property that cost over \$900,000; plans are to have a band shell and park in that location. Mayor Larson said that the County will not use the County's open space tax for developed property. The Mayor asked Bob Danna to poll the Taxpayers Association on their questions and concerns on the proposed open space tax for Harvey Cedars.

Mr. Danna asked if Harvey Cedars has an Affordable Housing Plan. The Mayor stated there is a plan that was done years ago and needs to be updated, but many changes have taken place with the COAH rules and the engineer is watching to see how this will affect us. The Mayor suggested perhaps the Taxpayers Association has members that are astute and would like to do pro-bono work for the town. Mr. Danna stated the Association was already considering collecting data, such as professions, in the membership drive.
