COMMISSIONER REPORTS/ TOPICS OF INTEREST

Commissioner Gieger shared that the snow and ice so far this winter has been tough on the borough. With temperatures staying in the single digits, salting the ice does not work. He added that the borough currently does not have a winter storm policy that would cover the exact rules for assisting residents and first responders. **Commissioner Gieger** explained that a policy would be created and adopted by Resolution in the next upcoming meetings.

With the large amount of instances where companies are cutting into Long Beach Boulevard, **Commissioner Gieger** shared that he is working on putting together a curb-to-curb ordinance. The ordinance would make these companies responsible for repaving the section of boulevard they are cutting into.

Commissioner Gieger shared that in partnership with resident Walt Naisby and ReClam the Bay, upwellers would be installed in Sunset Park.

Commissioner Rice shared that budget meetings will begin soon to work on the 2026 municipal budget.

Mayor Imperiale thanked Chief Robert Burnaford for his assistance through the January snowstorm and icy conditions. He added that due to the strong relationships that he has built with Ocean County representatives, that he was able to secure a free truckload of rock salt from the Ocean County yard in Ship Bottom. He reminded the attendees that the Harvey Cedars Beach

Patrol will be having a parade for their 10 consecutive Island Tournament wins.

PRIVILEGE OF THE FLOOR

Linda Kragie – 8 W. 75th Street – questioned the work that is being done on the boulevard and when it will wrap up. **Commissioner Gieger** shared that it is New Jersey Natural Gas and they are installing a new gas main that should take a few months.

Mindy Berman – 15 W. 80th Street – asked why the borough is responsible for fixing a watermain that New Jersey Natural Gas broke. **Commissioner Gieger** explained that there was an incorrect mark out so the responsibility falls on the borough and insurance does not cover it.

Kathy Ries – 29 Cedars Avenue – asked for clarification on Resolution 2026-016 and what the meaning behind increased bid thresholds is. CFO Rebecca Wessler explained that with a Qualified Purchasing Agent the bid thresholds for the borough increase to \$53,000.00 rather than \$17,500.00.

WHEREAS the Borough of Harvey Cedars desires to take advantage of the increased bid threshold.

NOW, THEREFORE, BE IT RESOLVED that the governing body of the Borough of Harvey Cedars, in the County of Ocean, in the State of New Jersey, hereby increases its bid threshold to \$53,000.00; and



**RESOLUTION AUTHORIZING THE HARVEY CEDARS POLICE DEPARTMENT TO
PARTICIPATE IN THE DEFENSE LOGISTICS AGENCY, LAW ENFORCEMENT
SUPPORT OFFICE, 1033 PROGRAM TO REQUEST AND ACQUIRE EXCESS
DEPARTMENT OF DEFENSE EQUIPMENT**

WHEREAS the United States Congress authorized the Defense Logistics Agency (DLA) Law Enforcement Support Office (LESO) 1033 Program to make use of excess Department of Defense personal property by making that personal property available to municipal, county and State law enforcement agencies (LEAs); and

WHEREAS DLA rules mandate that all equipment acquired through the 1033 Program remain under the control of the requesting LEA; and

WHEREAS participation in the 1033 Program allows municipal and county LEAs to obtain property they might not otherwise be able to afford in order to enhance community preparedness, response, and resiliency; and

WHEREAS although property is provided through the 1033 Program at no cost to municipal and county LEAs, these entities are responsible for the costs associated with delivery, maintenance, fueling, and upkeep of the property, and for specialized training on the operation of any acquired property; and

WHEREAS N.J.S.A. 40A:5-30.2 requires that the governing body of the municipality to approve, by a majority of the full membership, both enrollment in, and the acquisition of any property through, the 1033 Program.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Borough of Harvey Cedars that the Harvey Cedars Police Department is hereby authorized to enroll in the 1033 Program for no more than a one-year period, with authorization to participate terminating on December 31 of the current calendar year from January 1, 2026 to December 31, 2026; and

BE IT FURTHER RESOLVED that the Harvey Cedars Police Department is hereby authorized to acquire items of non-controlled property designated "DEMIL A," which may include office supplies and furniture, boats, boat motor, jet ski, plastic bags, cleaning equipment, range finders, scopes, gun parts, optical sighting, ranging equipment, compressor, rifle bag, flashlight, plastic bags, paper, computers, electronic equipment, generators, field packs, non-military vehicles, clothing, traffic and transit signal systems, exercise equipment, farming and moving equipment, storage devices and containers, tools, medical and first aid equipment and supplies, personal protection equipment and supplies, construction materials, lighting supplies, beds and sleeping mats, wet and cold weather equipment and supplies, respirators, binoculars, and any other supplies or equipment of a non-military nature identified by the LEA, if it shall become available in the period of time for which this resolution authorizes, based on the needs of the Harvey Cedars Police Department without restriction; and

BE IT FURTHER RESOLVED that the Harvey Cedars Police Department is hereby authorized to acquire the following "DEMIL B through Q" property, if it shall become available in the period of time for which this resolution authorizes, including but not limited to items such as utility trucks, ammunition cans, laser optics, armored vehicles, bulldozer, loader, backhoe, skid steer, portable light tower, transport vehicles, scopes, range finders, rescue equipment, tractor, ATV's, 4X4 vehicles, quad, computers, printer, air compressor, tractor, forklift, tools, traffic and transit signal systems etc.; and

BE IT FURTHER RESOLVED that the Harvey Cedars Police Department shall develop and implement a full training plan and policy for the maintenance and use of the acquired property; and


