COMMISSIONER REPORTS / TOPICS OF INTEREST

Mayor John Imperiale announced that beach replenishment will be starting in the upcoming weeks.

Commissioner Joseph Gieger shared that shells are being spread in the parking lots of Sunset Park. He shared that the water main project would be beginning soon and the borough parking lots on 80th street would be utilized for equipment overnight.

PRIVILEGE OF THE FLOOR

Jim Fritz - 1 W. 82nd Street - questioned the parking and seating requirements since parking is still an ongoing issue in the business district and creating a burden for residents. **Mayor Imperiale** explained that discussion on 2025:05 would take place at the March 17th meeting.

Hillary Fiorella -23 W. 80^{th} Street - asked where she could obtain a copy of the ordinances that were up for first reading. **Mayor Imperiale** shared that they would be posted on the website and bulletin board following the meeting.

Ashley Pelligrino – Black Eyed Susans – revisited the discussion on parking. She expressed that most homes have at least five bedrooms and barely enough parking to fit all of their own vehicles. **Ms. Pelligrino** shared that the bayfront homes in the business district areas are lacking in parking. **Mayor Imperiale** confirmed that the larger homes are now being required to offer more off-street parking.

Frederic Schragger – 7 E. Salem Avenue – questioned the parking plan that is proposed by a new potential restaurant in the borough. **Mayor Imperiale** shared that the application for that restaurant will come before the Land Use Board for approval.

Mary Ellen Vatalaro – 8408 Bay Terrace – asked if the borough has ever considered getting a traffic study done in the business district during the summer. **Mayor Imperiale** explained that he will be meeting with the county in March and a traffic study is on the list to discuss.

Ashley Pelligrino – Black Eyed Susans – asked if the blocking vehicles during the sidewalk construction would be able to be moved on the weekends when work isn't being done. **Mayor Imperiale** shared that the trucks must remain where they are per state law. **Commissioner Gieger** stated that the section being constructed this round is shorter so work time should be less.

Christopher Sanchez – Black Eyed Susans – questioned if there was a date for the information session on the road projects that are set to begin in the upcoming months. Commissioner Gieger shared that he met with the contractor in early February and the contractors are hoping to get the job started in early March. Commissioner Gieger added that equipment will be parked in the 80th Street parking lot over night and traffic will go down to one lane on the boulevard.

Moving away from the boulevard road projects, **Mr. Sanchez** questioned the boroughs stance on code enforcement on seating. **Mayor Imperiale** and **Commissioner Gieger** confirmed that the borough will enforce the law but seating will not be enforced in the off-season.

Ashley Pelligrino – Black Eyed Susans – asked if the borough had any intentions to add outdoor lights to the borough owned parking lot on 80th Street. **Commissioner Gieger** confirmed that no lighting would be installed due to a neighbor's request.

WHEREAS under current law, each municipality must individually make up for any lost revenue resulting from a parcel of property being exempted from property taxation because of its ownership by a 100% disabled Veteran; and

WHEREAS because the number of qualifying disabled Veterans varies from municipality to municipality, compliance with the State of New Jersey's policy to exempt disabled Veterans' property taxes impacts upon some municipalities more greatly than on others resulting in inequity; and

WHEREAS, the Mayor and Borough Council strongly support the Senator's legislation, S-2559, to end the inequity by having the State reimburse each municipality for the cost of complying with the State mandate of affording disabled Veterans with a total exemption from property taxation.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Borough of Harvey Cedars, County of Ocean, State of New Jersey, that:

- S1885 Broadens eligibility for certain veterans' benefits by elimination requirement of service during specified dates or in specified locations.
- S1888 Increases penalties for identity theft when victim is a senior citizen of veteran.
- S1891 Permits certain portion of municipal development trust funds to be spent on housing affordability assistance to veterans.
- S1895 Permits municipalities to charge reduced or no beach fee for children 12 to 17; revises law concerning beach fees for veterans.
- S1909 Designates State Highway Route 72 as "Burlington-Ocean Purple Heart Memorial Highway."
- S1915 Authorizes special Support Our Veterans license plate with proceeds supporting New Jersey homeless veteran's centers.
- S1921 Makes annual compensation pair to surviving spouses of certain blind or disabled veterans payable from date of veterans' death.
