Commissioner Gerkens stated the budget is not going up this year, it is remaining stable; she could not comment about the school or County budgets since they are not out yet; she stated the budget number may look as if it has increased but it is a "money in, money out" situation. Laura Cohen, CFO, explained the reimbursements from the State for the (beach) easements (money in) are used to pay down the debt incurred for the easements (money out); the (municipal tax) rate is staying stable and the amount to be raised through taxation is not being affected by those ins-and-outs.

Mike Songer asked if the same amount of increase is expected next year; he read in the paper about \$500,000 came in from the State and asked if that will be the same amount. The Board responded that the Borough is almost caught up with outstanding money (owed) from the State (regarding the easement acquisition cases); the money received pays down the BANs. Mayor Oldham added that there is one last case pending that had oral arguments

this week.

#### PRIVILEGE OF THE FLOOR –

Bob Danna asked about the status of dune and beach repairs. Mayor Oldham responded that we are waiting for the sand berm to come in, but the weather is not cooperating; DPW is working with the green tractor on the walkovers to get people down to the beach and they started putting up dune fence; consideration is being given to cut down the dune to gain access to the beach but we are trying to figure out how to get it done without leaving the beach vulnerable for any period of time; the longer we wait (for the sand to come back in) the better

are chances are, but the window of how much time to get it done gets smaller every day. The Mayor stated that the dredges (for the LBI replenishment) are back or close to being back; the State has promised we will get quite a bit of sand pumped on both ends of our town; we have a very good relationship with the State and Federal governments and they will do what they can to help us; the project is supposed to come back every 7 years dependent on funding. The Mayor had a conversation with LoBiondo's office regarding getting more funding.

Mike Songer asked about the school tax apportionment issue. The Mayor said the Ship Bottom school is the major concern right now; not everyone feels the same way about the tax apportionment, which is the problem. He said it would help if the other taxpayers' associations would get their towns on board about this issue. Bob Danno stated that at the last JCT meeting it was reported the Mayors of the other towns are still waiting to see what happens in Cape May.

Lena Nerrie asked about placing benches along the Boulevard for those who walk and would like a place to rest along the way. Commissioner Garofalo thought it is a great idea and will reach out to the Sisters (of Charity) to see if their area could be used and also look for other locations along the Boulevard.

Mike Songer asked if anything has been heard from the County regarding paving of the Boulevard. The Mayor said he has not heard anything; the Borough did send to the County road department the annual list of requests, but only received a thank you response.

John L. Vosseller, Elsie Vosseller and John L. Vosseller, Jr. for their dedicated public service, and recognizes that by and through their public service they have contributed greatly to making Harvey Cedars a better place to live; and

**WHEREAS** pursuant to NJSA 40:67-1 et. seq., the governing body of any municipality may provide for the naming and changing the names of streets; and

**WHEREAS** the Mayor and Commissioners of the Borough of Harvey Cedars feel that a lasting tribute to the Vosseller family for their contribution to the Borough is to rename the street they have resided on and where they have enjoyed all of their lives.
