The Board stated that it is private property, no commercial business is allowed, and the property is wetlands that is enforced by the DEP. It was reported that Mr. DiDonato will be holding a meeting with the neighbors on Friday, and access issues should be addressed with him.

Roby McClellan, 78th Street, thanked the Board for Rob Burnaford becoming the Chief of Police, and also thanked the Board for the pickleball court.

Mr. Kiely asked why the taxes significantly went up a year ago. Commissioner Gerkens and the Mayor stated it was the school and County budgets that went up, the Borough's has remained stable; the formula for school taxes is based on a ratio of high school and grade school students; the County taxes were effected by ratables going down in other Ocean County towns due to Superstorm Sandy.

Ms. McBrair informed the Board about playground mulch regulations regarding depth. The Mayor stated it should be 12".

The Mayor stated Public Works is working on the beach trying to fix it for the holiday weekend.

AN ORDINANCE OF THE BOROUGH OF HARVEY CEDARS, OCEAN COUNTY, NEW JERSEY AMENDING AND SUPPLEMENTING CHAPTER 13 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF HARVEY CEDARS, 1975, ENTITLED "ZONING" AS IT PERTAINS TO BULKHEAD PERMIT FEES

BE IT ORDAINED BY THE BOARD OF THE COMMISSIONERS OF THE BOROUGH OF HARVEY CEDARS, as follows:

Section 1. Section 13-16.2 entitled "Certificates and Permits" paragraph a.2(1) is hereby supplemented as follows:

(1) Bulkhead permit - \$50.00

- <u>Section 2</u>. This Ordinance repeals any inconsistent ordinance or ordinances or part of parts thereof.
- <u>Section 3</u>.
