

Due to the COVID-19 pandemic and the New Jersey Governor's Executive Order No. 107, the shelter in place order effective March 21, 2020, the regular meeting of the Board of Commissioners of the Borough of Harvey Cedars, NJ was hosted by the Municipal Clerk via Zoom in the Borough Hall meeting room with Mayor Oldham, Commissioner Imperiale, Commissioner Rice and 3 Borough employees in attendance. The public was able to join the meeting via Zoom; 3 members of the public were Zoomed-in.

The meeting was called to order by Mayor Oldham at 4:30pm.

The Mayor asked all to rise for the Pledge of Allegiance; the flag in the meeting room was shown on the screen.

The Mayor stated to the best of his knowledge all the requirements of the Sunshine Law have been met. Pursuant to the applicable portions of the New Jersey Open Public Meetings Act, adequate notice of this meeting has been given. The schedule of this meeting of the Board of Commissioners of the Borough of Harvey Cedars is listed in the notice of meetings posted on the bulletin board located in the Borough Hall and the Borough's website and was published on January 9, 2020 in the Beach Haven Times and the Asbury Park Press. N.J.S.A. 10:4-8(b) authorizes local units to conduct public meetings through use of streaming services and other online meeting platforms. Notice of the meeting being held remotely via Zoom was posted on the website on June 9, 2020 and published in the Beach Haven Times on April 2 and 9, 2020.

The Mayor stated this is the last Borough Zoom meeting, the next one will be open to the public, but will be limited to a total of 14 people in the room.

Wendy McBair expressed her concerns and the need to move forward with the purchase. The Mayor said he was pleased that the neighbors had recontributed the same amount to Save Barnegat Bay.

AN ORDINANCE OF THE BOROUGH OF HARVEY CEDARS APPROPRIATING THE SUM OF \$39,000 FROM THE GENERAL CAPITAL IMPROVEMENT FUND FOR CERTAIN CAPITAL IMPROVEMENTS IN THE BOROUGH OF HARVEY CEDARS

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE BOROUGH OF HARVEY CEDARS as follows:

Section 1. Pursuant to the applicable statutes of the State of New Jersey, there is hereby authorized the capital improvements within the Borough of Harvey Cedars as follows:

- A. For the purchase of beach mats and supplies for handicap access to beaches and all work necessary therefore and incidental thereto, there is hereby appropriated the sum of \$39,000.00.

Section 2. This Capital Improvement Ordinance is to be financed from the capital funds that the Borough presently has on hand.

ORDINANCE NO. 2020-11

AN ORDINANCE OF THE BOROUGH OF HARVEY CEDARS AMENDING AND SUPPLEMENTING CHAPTER 8 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF HARVEY CEDARS, 1975, ENTITLED “TRAFFIC” AS IT PERTAINS TO TRAILERS AND RECREATIONAL VEHICLES

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE BOROUGH OF HARVEY CEDARS as follows:

Section 1. Section 8-3.7 entitled “Trailers Prohibited” is hereby amended by renaming said title as “Trailers”.

Section 2. Section 8-3.7 paragraph a. entitled “All Trailers” is hereby amended by renaming said title as “Trailers Prohibited”.

Section 3. Section 8-3.7 paragraph b. entitled “Trailers - Watercraft” is hereby repealed in its entirety and replaced by paragraph b. entitled “Parking and Storage of Trailers” and supplemented as follows:

b. Parking and Storage of Trailers

1. Trailers are permitted to be parked or stored on private property.
2. Trailers are permitted to be parked on public paved streets when attached to a motor vehicle unless otherwise prohibited.

Section 4. Section 8-3 entitled “Parking” is hereby amended and supplemented with new Section 8-3.9 entitled “Recreational Vehicles – Occupancy and Utility Connections” as follows:

8-3.9 Recreational Vehicles – Occupancy and Utility Connections.

- a. It shall be unlawful for any person to occupy or otherwise reside within, or in any manner relating thereto, any recreational vehicle, camper, trailer or other mobile structure while it is being parked or stored on any residential or commercial lot, or on any public roadway or easement.
- b. It shall be unlawful for any person to connect any recreational vehicle, camper, trailer or other mobile structure to water, natural gas, or sanitary sewer service while being parked or stored within the Borough.

Section 5. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

Section 6. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions.

Section 7. This Ordinance shall take effect upon final adoption after publication in accordance with law.

STIPULATION OF SETTLEMENT

BOROUGH OF HARVEY CEDARS AND PBA LOCAL 175

WHEREAS, the Borough of Harvey Cedars (Borough) and PBA Local 175 (PBA) are parties to a series of collective negotiations agreements (CNAs), the most recent of which covers the period of January 1, 2017 to December 31, 2020;

WHEREAS, the PBA is the collective negotiations representative for all regular full-time police officers employed by the Borough excluding the Chief of Police (Bargaining Unit);

WHEREAS, Article V sets forth the work schedule for each member of the Bargaining Unit. As of October 31, 2019, the officers were scheduled to work 12-hour tours of duty wherein an officer would work 48 hours one week and 36 hours the following week. The Borough provided each officer with paid ‘Kelly Time’ annually in the amount of 104 or 112 hours;

WHEREAS, on October 1, 2019, Chief of Police Burnaford issued special Order No. 19-06. Pursuant to said Order, effective January 1, 2020, the work schedule for each police officer was changed to 10-hour shifts.

WHEREAS, the PBA challenged the change in the work schedule by filing both a grievance as well as an Unfair Practice Charge;

WHEREAS, the grievance was subsequently eventually submitted to arbitration and the New Jersey Public Employment Relations Commission (PERC) assigned the matter PERC Docket No. 2020-229 and appointed Arbitrator Wendy Young to preside over this dispute. The arbitration is currently scheduled for September 11, 2020;

WHEREAS, the Borough filed a Petition for Scope of Negotiations Determination (Scope Petition) to restrain the arbitration of the aforesaid grievance. The Scope Petition has been assigned PERC Docket No. SN-2020-028 and is currently pending;

WHEREAS, the PBA’s Unfair Practice Charge was assigned PERC Docket No. CO-2020-134 and is also currently pending; and

WHEREAS, parties are desirous of resolving the above-referenced disputes amicably.

NOW, THEREFORE, BE IT RESOLVED that, in full and final settlement of the above captioned matters and all related issues, the parties hereby agree to the following terms and conditions:

1. By entering into this Agreement, neither party is admitting to any wrong doing or any violations of the parties' collective negotiations agreement or any provision of the New Jersey Employer-Employee Relations Act.
2. The 10-hour schedule at issue in the above-referenced matters shall remain in effect up to and including August 31, 2020;
3. Effective September 1, 2020, the work schedule shall be changed so as to reflect the following:
 - (a) Sergeants shall work 10-hour shifts. The parties retain the existing ability for either to "flex" the regularly scheduled work hours by up to two (2) hours per daily assigned shift; and
 - (b) Starting on July 1, up to and including August 31 of each year, Patrol Officers shall be assigned to a ten (10) hour work shift. During the balance of the calendar year, Patrol Officers shall be assigned as follows: during a 14 day cycle officers shall work six 12-hour shifts and one 8 hour shift. Said officers will not be entitled to any "Kelly Time" as one shift in each 14 day cycle shall only be 8-hours in duration.
4. Article V, Paragraph A(1) and (2) of the parties' 2017-2020 CNA shall be hereby amended, effective September 1, 2020, to reflect the 14 day/80-hour cycle described in Paragraph 3 above; and
5. Upon ratification and the full execution of this Stipulation of Settlement, this Agreement shall constitute the Borough's withdrawal with prejudice of the pending Scope Petition, PERC Docket No. SN-2020-028, as well as the PBA's withdrawal with prejudice of its pending grievance arbitration, PERC Docket No. AR-2020-229, and Unfair Practice Charge, PERC Docket No. CO-2020-134.
6. The parties represent that all requirements for ratification have been met prior to signing this document.
