The regular meeting of the Board of Commissioners of the Borough of Harvey Cedars, NJ was called to order by Mayor Oldham at 4:30pm. Commissioners Gerkens and Garofalo were present.

Public Property Usage requests:

1. Therapeutic Yoga Classes – Sunset Park

A discussion was held regarding the request by Marion Cianci for therapeutic yoga classes on Fridays in July and August from 8:30am to 9:45am. The Board's concern was that there is a yoga business in town that may present a conflict. The request was denied. (NOTE: after the meeting adjourned, a resident that was not present at the time of this discussion explained the differences of therapeutic yoga and the yoga provided at the business. The Commissioners agreed that this request be approved.)

PRIVILEGE OF THE FLOOR -

Jim Loudon reported he attended the local Board of Education meeting; the Board is waiting for supporting resolutions from the towns regarding the sale of the LBI School. James Donahower, School Board Representative for Harvey Cedars, stated the Board of Ed is merely seeking support from the towns at this time, and no formal action is necessary yet.

Jim Loudon asked about the striping of another pickleball court. The Mayor asked the clerk to order striping for the other court.

Bettie Greber, East 80th Street, voiced her complaint regarding no handicap access to the beach. Her granddaughter read a statement regarding State statutes and handicap accessibility. The Mayor explained that Public Works has been concentrating on restoring the beach, which put other projects on hold; they should be done in about a week; he would like to schedule a meeting with the neighbors to finalize the handicap parking spot and bike rack. The Mayor asked the Chief, who was in attendance, if a lifeguard and ATV can be used for beach access; Ms. Greber stated she could not use an ATV; Commissioner Garofalo suggested perhaps the police "mule" would be a better ride.

Todd Rendfrey, 17 James Street, submitted an engineer's survey of Block 1 Lot 2 dated 6/27/2016. It includes the street end of James Street and depicts the Borough's right-of-way and dune fencing that is in in the right-of-way. Also in attendance from James Street were Ted Einhorn, Sue Rendfrey, Joe Kiely, Susan Carril, and from William Street Irwin Sablosky, who all gave comments and participated in the discussion of the wetlands property on James Street, Block 1 Lot 1. The residents voiced their concerns regarding Mr. DiDonato's use of the wetlands, the right to the mean high water line and the fencing erected in the right-of-way. Mr. Rendfrey stated there is a small section of land between Mr. DiDonato's property line and his bulkhead where people can access the water. In summary, the residents requested the dune fencing be removed immediately from the Borough's right-of-way and also the camera that is on a tree in the right-of-way. The Mayor stated he will have the Borough Engineer verify the right-of-way location prior to asking Mr. DiDonato to remove the fencing and camera.

services through the use of a nationally-recognized and accepted cooperative purchasing

agreement that has been developed utilizing a competitive bidding process by another contracting

unit within the State of New Jersey, or within any other state, when available; and

WHEREAS the nationally-recognized National Joint Powers Alliance Cooperative

Pricing System, hereafter referred to as NJPA, has offered voluntary participation in the national

cooperative purchasing agreement for the purchase of goods and services; and

WHEREAS it is the desire of the Borough of Harvey Cedars to join the NJPA to purchase

goods and services to make the procurement process more efficient and to provide cost savings to

the Borough; and

WHEREAS the Public Works Department is in need of a compact loader for use

throughout the Borough for daily operations; and

WHEREAS the NJPA has entered into a contract #032515-CAT with Caterpillar, Inc. for

heavy construction equipment, including a CAT Model 249D CCE compact track loader.

NOW, THEREFORE, BE IT RESOLVED by the governing body of the Borough of

Harvey Cedars, County of Ocean, State of New Jersey as follows:

1. The Superintendent of Public Works/Water/Sewer and the Municipal Clerk are hereby

authorized to enter into a member participation agreement with the National Joint Powers
