ORDINANCE NO. 2021-21

AN ORDINANCE OF THE BOROUGH OF HARVEY CEDARS AMENDING AND SUPPLEMENTING CHAPTER 8 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF HARVEY CEDARS, 1975, ENTITLED "TRAFFIC" AS IT PERTAINS TO PARKING TIME LIMITS

WHEREAS streets are primarily used for transportation and short-term parking, not for long-term parking; and

WHEREAS residential areas provide parking for commercial establishments generating traffic congestion; and

WHEREAS it is the desire of the Board of Commissioners to set time limits for parking on the streets of the Borough, create more parking availability, and lessen traffic in residential areas.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE BOROUGH OF HARVEY CEDARS as follows:

- Section 1. Chapter 8 of the Borough Code of the Borough of Harvey Cedars, Section 8-3.5 entitled "Parking Time Limited on Certain Streets" is hereby deleted in its entirety and replaced with Section 8-3. entitled "Parking Time Limited" as follows:
 - 8-3.5 Parking Time Limited. No person shall park a vehicle in any one spot upon any of the streets or parts of streets within the Borough for longer than seven (7) consecutive days other than directly in front of the person's own property.

No person shall park a vehicle for longer than the time limit shown in Schedule IV at any time between the hours listed in Schedule IV of any day upon any of the streets or parts of streets described in Schedule IV attached to and made a part of this chapter.

Section 2. Chapter 8 of the Borough Code of the Borough of Harvey Cedars, Schedule IV is hereby amended and supplemented as follows:

West 80^{th} Street, North Side, parking spaces adjacent to the Borough property, Time Limit 3 hours

- <u>Section 3</u>. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.
- Section 4. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions.
- Section 5. This Ordinance shall take effect upon final adoption after publication in accordance with law.

AUTHORIZING EXECUTION OF INTERGOVERNMENTAL AGREEMENT WITH THE COUNTY OF OCEAN FOR PURCHASE OF MATERIALS AND SUPPLIES FOR THE 2022 ROAD & TRAFFIC LIGHT MAINTENANCE (SCHEDULE "C")

WHEREAS the County of Ocean has created and established a program to assist municipalities and governmental agencies in the repair and maintenance of municipal streets and property in addition to providing certain materials and supplies in connection therewith; and

WHEREAS the governing body of the Borough of Harvey Cedars has requested the County to provide certain materials and supplies for the maintenance of roads, property and traffic signals within the municipality for the year 2022 at a cost not to exceed \$11,000.00; and

WHEREAS the Borough of Harvey Cedars wishes to enter into an agreement with the County for the provision of these services.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE BOROUGH OF HARVEY CEDARS, STATE OF NEW JERSEY as follows:

- 1. The Mayor and Clerk of the Borough of Harvey Cedars are hereby authorized and directed to enter into and execute an Intergovernmental Agreement with the County of Ocean for the provision of materials, supplies and services in an amount not to exceed \$11,000.00 as more specifically set forth in that Agreement and to be allocated as follows:
 - a. Ocean County Road Department \$ 10,000.00
 - b. Ocean County Engineering Department \$ 1,000.00
- 2. A copy of the Agreement shall be kept on file and be available for public inspection at the Office of the Borough Clerk.
- 3. This Agreement shall take effect upon full execution by the parties and shall remain in full force and effect through December 31, 2022. Sufficient funds have been appropriated and are available for this purpose in the 2022 municipal budget.
